Ja, dolje potpisani službeni veterinar, ovim potvrđujem da životinje opisane u ovom certifikatu: / I, the undersigned official veterinarian, hereby certify, that the animals described in this certificate:

II.1.1. dolaze s gospodarstava na koja se nisu primjenjivale službene zabrane zbog zdravstvenih razloga u prethodna 42 dana u slučaju bruceloze, u prethodnih 30 dana u slučaju bedrenice i u zadnjih šest mjeseci u slučaju bjesnoće te nisu bile u kontaktu sa životinjama s gospodarstava koje ne udovoljavaju ovim uvjetima; / come from holdings which have been free from any official prohibition on health grounds, for the past 42 days in the case of brucellosis, for the past 30 days in the case of anthrax and for the past six months in the case of rabies, and, have not been in contact with animals from holdings which did not satisfy these conditions;

II.1.2. nisu tretirane: / have not received:

- stilbenima ili tireostaticima, / any stilbene or thyrostatic substances,

(1) ili/ or [(d) nisu bile slobodne od plavog jezika u proteklih 24 mjeseca, i životinje su cijepljene, najmanje 60 dana prije datuma otpreme u BiH, protiv svih serotipova plavog jezika (unesi serotip/ove) koji su prisutni u populaciji kao što je pokazao kroz programa nadziranja⁽⁵⁾ u mjestu i 150 km radiusa oko (ima) podrijetla opisanom u rubrici I.11., a životinje su još uvijek unutar razdoblja imuniteta jamčen u specifikaciji cjepljiva;/has not been free for 24 months from bluetongue, and the animals have been vaccinated with an inactivated vaccine, at least 60 days before the date of dispatch to the Union, against all bluetongue serotype/s (insert serotype/s) which are those present in the source population as demonstrated through a surveillance programme⁽⁵⁾ in an area with a 150 km radius around the holding(s) of origin described under box reference I.11., and the animals are still within the immunity period of time guaranteed in the specifications of the vaccine]

II.2.6. U vezi s grebeži ovaca/ In respect of scrapie:

(1) *both/ either* [II.2.6.1. rođene su i bez prekida uzgajane na gospodarstvima na kojima slučaj grebeži ovaca nikad nije dijagnostičiran/ **were born in and continuously reared on holdings in which a case of scrapie has never been diagnosed;**

Ovaj certifikat odnosi se na žive domaće ovce (*Ovis aries*) i domaće koze (*Capra hircus*) namijenjene uzgoju i/ili proizvodnji. / **This certificate is meant for live domestic ovine animals (*Ovis aries*) and domestic caprine animals (*Capra hircus*) intended for breeding or production.**

Nakon uvoza životinje moraju biti bez odlaganja otpremljene u određenu klaonicu na klanje unutar roka od 72 sata nakon uvoza u BiH. / **After importation the animals must be conveyed without delay without delay to the slaughterhouse of destination to be slaughtered within 72 hours after importation into BiH.**
